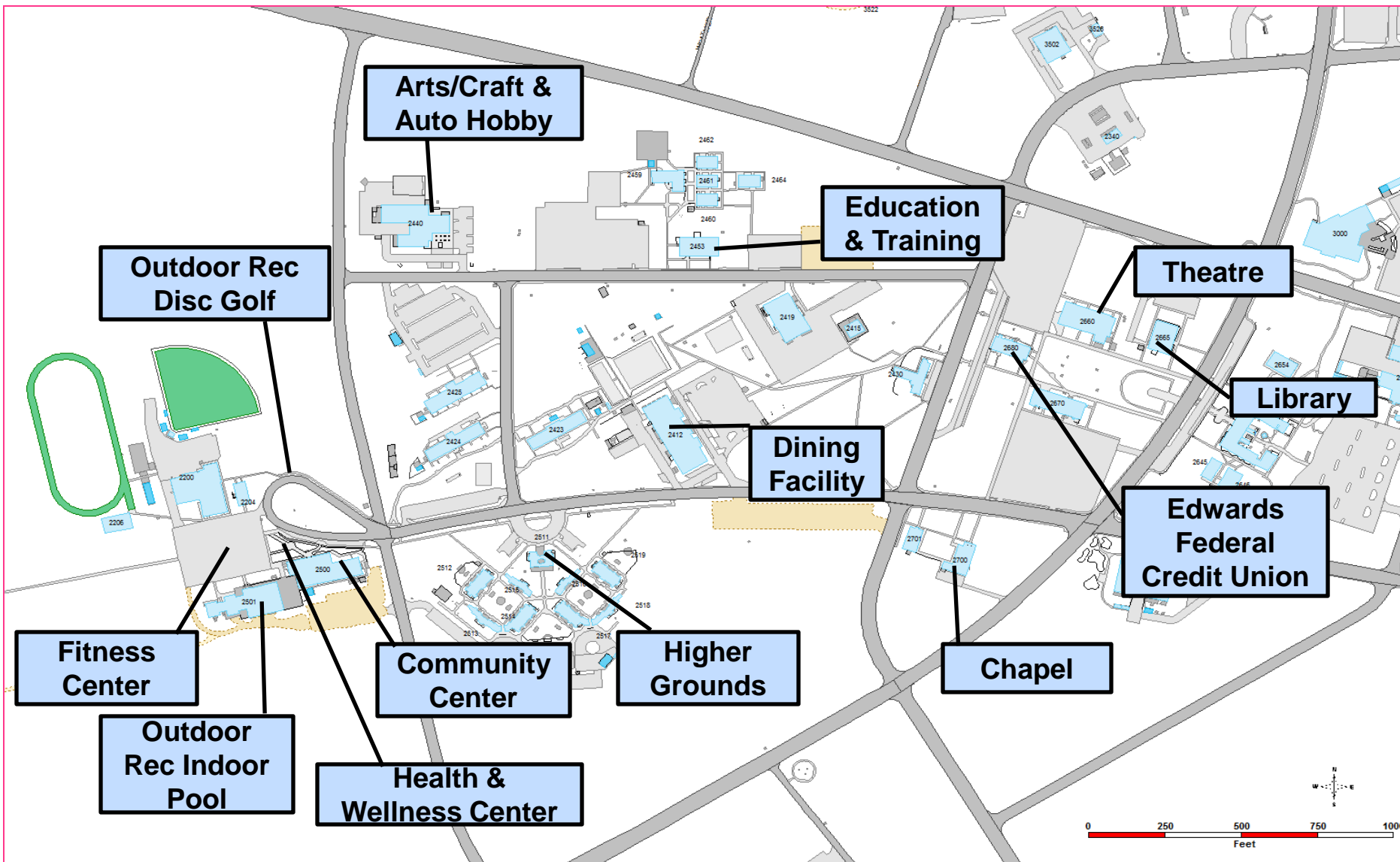

Financial Management FAQs



- **What are you currently receiving?**
 - Members are currently receiving \$325.04 for BAS and will continue to receive this entitlement. Meal deductions will show in the deductions column of LES
- **How much are Meal Deductions?**
 - Meal deductions are \$9.25 daily



Financial Management FAQs



- **What changes should be expected in pay?**
 - 01 Nov 11 LES: Deductions should read \$157.25 for the month of October. 17 days (15-31 Oct) x \$9.25/day = \$157.25
 - NOTE: If your 01 Nov 11 LES does not reflect Meal Deductions, the deductions will be reflected on your 15 Nov check as \$296.00 (15 Oct-15 Nov) and 01 Dec 11 as \$138.75 (16-30 Nov11). Your Meal deductions on your 01 Dec 11 LES will read \$434.75
- **Are there any special circumstances in regards to meal deductions?**
 - While members are on LEAVE, meal deductions will not be charged. There is no special transaction that needs to occur, the changes will be corrected when the leave is charged to the member's record.
